and we will find out in November. SPARK grant for the Lions Park improvements results should be in during month of March and Water Reliability Study is in process with Spicer and EGLE and we will find out in April if we will receive funding for leak detection. The Blacks Corners Road Project with OHM Engineering will be going out for bid in April and May ready for construction when the schools are out and be completed before school begins in the fall. Lamb Steele HVAC Project will be ready to go out to bid soon. Also, we are currently working on a DNR Grant for the trail head of Polly Ann Trail. Priehs described the two water main leaks that happened recently and explained that this is an example of infrastructure from the 30s.
