Waste Water Treatment Plant Supervisor Pat Rankin informed the Commission that a splitter box at the Waste Water Treatment Plant has started leaking after settling and is going to become a serious problem without repair or replacement. Rankin gave two options after an engineer review for fixing: First option - shoring up the splitter box, resealing it and hoping it does not settle again.

Second option - getting rid of the spitter box and running pipe in place of this. The cost of this repair is possibly \$100K to \$200K. We will have to get quotes and fix this very soon. In addition, Rankin updated the Commission on the lift station replacement that was part of the M-53/4th Street project as they are still waiting for parts to come in due to supply chain issues. Currently the Waste Water Treatment Plant staff have been pulling up the lift station manually twice per week while waiting for this new unit to be installed.

The Police Department would like to set up a Fund for the revenue from these items as is the proper way to handle this.

City Manager Horton and Sawicki-Franz informed the City Attorney Robert Seibert of the initiative and the lack of the number of signatures required. After informing the petitioners, they have now filed a lawsuit and we will be in court next week regarding this situation.

City Manager Horton said he has three quick updates for the Commission: 1) City Manager Horton and DPW Superintendent Priehs met with contractors and utility companies regarding the Blacks Corners Road Project and this should begin soon after Labor Day and be completed by the end of September. After reaching out to Imlay Township Supervisor Rick Farkas regarding this project due to a very small portion of the Blacks Corners Road project area being in the township, Farkas will be contacting the Lapeer County Road Commission and requesting that the Imlay Township portion be included for the resurfacing project. 2) SPARKS grant process is moving along and in the RFP process for Prime Administrator as this needs to be approved by the organization running the SPARKS grant. 3) The Baptist Church on Almont Avenue has dissolved. This property is located adjacent to the Rotary Park and in a flood plain. City Manager Horton has reached out to the organization in Vermont, OH and asked about the possibility of donating or an inexpensive sale to the City of this property.

Commissioner Collison thanked Waste Water Treatment Plant Supervisor Rankin for the hard work he and his team puts in each day at the plant.

Commissioner Tanis said he will be returning home from the job site on Friday and will be available more often in the City in the near future.

Commissioner Sadler expressed his excitement with the "Off the Rails" training event that is scheduled for Saturday, September 28th, 2024 with Sarah Whaley, the Emergency Management Coordinator of Lapeer County.
