FROM THE IMLAY CITY POLICE DEPARTMENT



When it comes to public safety, in an emergency we all want to make sure first responders get to our homes quickly, safely and efficiently. Sometimes the efficiency is hindered by traffic, weather or worse, not being able to find the right address because of the lack of address numbers identifying your home. An ordinance passed by the Imlay City Commission back in 1994 set forth the guidelines of businesses and residential homes requiring address numbers for both. The Police Department and Fire Department want to avoid hesitation and wasting time guessing on house numbers of our residents.

This is why Imlay City Fire Chief Keith Klobucar and Imlay City Police Chief Brett Selby are asking all Imlay City Residents to spruce up, fix up or put up visible address markers on their homes according to the ordinance specifications below. Code Enforcement Officer Charles Cutajar will be reminding residents street by street to get their address numbers on their homes ASAP for their safety and our efficiency. On behalf of the Public Safety Department, we want to **THANK YOU** for making our job easier.

§ 97.01 ADDRESS NUMBER REQUIRED.

Each dwelling and each principal building within the city shall obtain and display an assigned address number. An address number shall only be issued for a public or private street.

§ 97.02 DEFINITIONS.

PRINCIPAL BUILDING. The main building located on a parcel or lot. Garages, pole barns, and other buildings which are normally accessory to other structures shall not be deemed to be principal buildings unless they are provided with a separate electrical meter.

PRIVATE STREET. A non-public street which has been approved by the city in compliance with city ordinances. Easements and private drives shall not be deemed to be private streets.

§ 97.04 POSTING.

Each dwelling or other principal building on a parcel of land within the city shall post the assigned address number. The number must be visible from the street. Whenever a dwelling or principal building is located more than 100 feet from the center of a public or private street, or is otherwise difficult to see from the street, the owner shall post the address number at the point at which the driveway enters the public or private street.

§ 97.05 NUMERALS.

Each posted address number shall consist of numerals at least three inches in height and of a contrasting color to the attached surface.

§ 97.07 MULTIPLE ADDRESS NUMBERS.

Developments which need individual address numbers for locations within the site shall comply as follows:

(A) Mobile home parks. The mobile home park shall be assigned a single address number for the public road on which the park is located. Individual home sites within the park shall be designated by that address number plus the lot number of the site. Lots shall be consecutively numbered. Each internal street shall have a continuously maintained sign indicating the range of lot numbers on that street.

(B) Multiple family dwellings. Each individual building shall receive an address number. Each unit within that building shall receive a number which includes the building address number plus a number indicating the floor and the unit.

(C) Multiple unit buildings. All other principal buildings containing more than one unit shall receive an address number. The individual unit number shall be determined by the enforcement agency based upon the layout and location of the structure.

FROM THE DESK OF ED PRIEHS, DPW SUPERINTENDENT

Winter is here, residents and businesses should be aware or reminded of an amendment in 2023 to the Code of Ordinances: General Regulations – Snow Emergencies Ordinance No. 8.2C. In the Ordinance, the City may declare a Snow Emergency if forecasted weather conditions make it necessary that motor vehicle traffic be expedited and that parking on the streets of the City be prohibited or restricted for snow plowing and other purposes. The City will announce such parking prohibitions or restrictions on all communication outlets at its disposal. The parking prohibitions will commence one hour after declaration of a snow emergency. Parking prohibitions will remain in effect until terminated by announcement of the City. Also, during or after all snow events, please do not plow, blow, shovel, or place snow onto or across the street. It is against the law and is dangerous for all motorists. When this occurs, it removes or weakens the effectiveness of de-icing materials that have been applied to the streets. Piles of snow and ice left in streets can cause damage to vehicles and snow removal equipment. Please be patient, and do not drive close to salt trucks and snow removal equipment. These trucks and equipment will back-up from time to time during salting and snow removal operations. Thank you for your cooperation, the DPW is committed to streets and roads in the City being clear and safe for all motorist.



FROM THE OFFICERS AND STAFF OF THE IMLAY CITY FIRE DEPARTMENT



Welcome to Winter. Here are some critical items to consider as you embrace and enjoy this time of year.

December, January, and February bring colder temperatures and the use of home heating equipment. A few safety rules to remember are to keep anything that can burn at least three feet from any heat source (fireplaces, wood stoves, radiators, space heaters, etc.). Only plug in one heat-producing appliance (space heater, etc.) to an electrical outlet at a time. Avoid using extension cords with a heating device; the cords are not rated for the device's electrical current, causing them to overheat and melt.

Ensure you have working smoke and carbon monoxide (CO) detectors in your home. It is recommended that you check the CO detectors monthly. If you are using a generator to provide power to your home, keep the generator outside, away from windows, and as far away from your home as possible. If you use your fireplace, please keep your cooled ashes in a tightly covered metal container stored at least 10 feet from your home or nearby buildings.
